- 2) Reality

3) Responsiveness

Responsive attitude here at the time of providing the service needed and can complete it quickly. The timing of the services provided is the response of the officer to provide the necessary services. Responsivity here is the result of reasoning and reflection directed to society.

4) Assurance

Assurance here covers the knowledge, potential, decency, and reliability of the officers, free from danger, and risk. The guarantee here is an effort of protection aimed at the society against the risks that occur.

5) Empathy

Empathy consists of the ease of relationships, effective communication, and understanding the needs of society. Empathy is the care that a person gives to an individual by placing himself in a position in society. On the side of empathy, the apparatus has already sought to create good communication to society.

- 5) Equal rights are services that do not differ on the basis of forms such as tribe, race, religion, social status and other.
- 6) The balance of rights and duties is a service that takes care of the fairness of the provider and recipient of services.

The word quality has different meanings and ranges from conventional to more strategic. The definition of quality often describes the immediate characteristics of a product, namely (Putri, 2016):

- Esthetic
